## **NOTIFICATION OF CONFIDENTIALITY**

CROWNE PLAZA, ATHENE PALACE HILTON (Bucharest), EUROPA (Eforie Nord), BRADUL, SPORT and POIANA (Poiana Brasov) belong to ANA HOTELS SA. Below you can find information that explains how we collect personal information when booking a stay on Booking.com.

## **WHAT INFORMATION DO WE COLLECT YOU ABOUT YOU?**

Booking.com sends us all the information that you have personally filled in on your website, less your private email address.

## **HOW DO WE USE YOUR INFORMATION ABOUT YOURSELF?**

All this information is legally required to guarantee your reservation and to be accommodated in our hotel. In order to confirm the reservation, we will check the bank card used by you to guarantee with the help of the bank BRD - GROUPE SOCIETE GENERALE, the partner who offers us this service. If, for various reasons, we will have to contact you before staying in our hotel, we will do so only through the generic e-mail address provided by Booking.com. We do not sell or send your data to other entities. They are stored in our servers for a period of 24 months after your last stay with us, and then they are automatically deleted.

## **MARKETING**

We will not send you any information about our hotel because we cannot contact you directly. During the accommodation procedure, if you wish, you can directly provide us with your personal email address and you can give us your agreement to keep you up to date with our offers. If you have accepted this, you can always opt out of receiving offers from us through a simple unsubscribe process.

## **ACCESS TO INFORMATION, DATA RECTIFICATION AND COMPLAINTS**

We want to make sure that all your rights are respected and that your personal information is fully protected. You may request a copy of the information we hold about you, ask for the data to be rectified or deleted, or request restriction of the data processing.
