## **NOTIFICATION OF CONFIDENTIALITY**

## **WHAT INFORMATION DO WE COLLECT YOU ABOUT YOU?**

In order to make an online booking using ANA HOTELS' own reservation platform, we need the following personal data: first and last name; phone number; your e-mail address. To guarantee your reservation, we ask for some information about your bank card. The phone number and e-mail address are required to inform you about the status of your booking request.

## **HOW DO WE USE YOUR INFORMATION ABOUT YOURSELF?**

All this information is legally required to guarantee your reservation and to be accommodated in our hotel. In order to confirm the reservation, we will check your bank card for guarantee with the assistance of BRD - GROUPE SOCIETE GENERALE, the partner who offers us this service. If, for various reasons, we will have to contact you before staying in our hotel, we will do so at the email address you have provided.

We do not sell or send your data to other entities. They are stored in our servers for a period of 24 months after your last stay with us, and then they are automatically deleted.

## **MARKETING**

We will not send you any marketing information about our hotels. During the accommodation procedure, if you wish, you can give us your consent to keep you informed on our offers submitted to your personal email address. If you have accepted this, you can always opt out of receiving offers from us through a simple unsubscribe process.

## **ACCESS TO INFORMATION, DATA RECTIFICATION AND COMPLAINTS**

We want to make sure that all your rights are respected and that your personal data is fully protected. You may request a copy of the information we hold about you, ask for the data to be rectified or deleted, or request restriction of the data processing.
