



## **Hotel Updates: COVID-19**

Goodwood Park Hotel stands united with Singapore's efforts against the COVID-19 pandemic. Protecting the safety and well-being of our guests and staff will always be the Hotel's utmost priority.

In compliance with safe management measures from 22 November 2021, please be informed:

- A maximum of 5 guests are allowed in the hotel room or inter-accessible hotel rooms at any one time (including registered guests and/or visitors) except where they are all from the same household. Only up to 3 registered guests (or up to the room's maximum capacity) are allowed to stay the night after 10pm.
- In accordance with Singapore Government border measures, the Hotel requires additional documentation from guests travelling via Air Travel Pass, Reciprocal Green Lane or Vaccinated Travel Lane to validate identity, travel itinerary and other relevant information within existing guidelines. Necessary documentation has to be provided at least 3 days prior to arrival, if not the reservation will be cancelled. Please note that limited room categories are available for such bookings so it is necessary to contact the hotel before booking confirmation. The hotel also does not accept bookings for self-quarantine or self-isolation reasons. For assistance with bookings or enquiries on [staycations](#), please contact [Room Reservations](#).
- Use of the Fitness Centre will only be allowed for up to 3 fully vaccinated guests at any one time (please refer to Pg 2). Use of the swimming pools are limited to maximum 5 persons per group. Safe management protocols, including requirements for pre-bookings and capacity limits are in place for the Hotel's two swimming pools and Business Centre.
- The Hotel-operated restaurants are open for dine-in, for a maximum of 5 fully vaccinated persons per table (please refer to Pg 2) and safe distancing of 1m between tables. Splitting across tables for a larger group is not permitted unless they are from the same household. Intermingling between tables is not allowed. Sales and consumption of alcohol at/from all F&B establishments are prohibited from 10.30pm. Guests can choose to enjoy [dining experiences](#) in our restaurants, enjoy in-room dining service or [order delivery](#) to savour our cuisine in the comfort of their homes.
- Marriage solemnisations and MICE events can be held with a maximum of 1000 fully vaccinated attendees; up to only 50 persons (limited to 2 persons per group) if any are unvaccinated. 1 wedding reception per couple will only be allowed for a maximum of 250 fully vaccinated attendees at group sizes of 5. Please refer to Pg 2. Mandatory safe management measures will be in place including individual venue capacity limits, different group size limits within the event and F&B service. We are committed to ensuring a safe and clean environment for everyone as well as providing peace of mind for our guests' experience. Precautionary measures at the Hotel include:

- Increased frequency of cleaning, disinfection and sanitisation across all areas of the hotel, including high touch surfaces like lift buttons and door handles.
- Hand sanitisers available around the Hotel in public and staff areas. Hand sanitiser and masks are also provided as guest room amenities.
- Use of Singapore's SafeEntry digital system to record entry and exit information of guests and staff for contact tracing purposes. This is also applicable for entry into the Hotel's restaurants and facilities.

- Daily health declarations and contactless temperature screening for staff, with the addition of weekly Antigen Rapid Testing (ART) for relevant staff.
- Safe management measures implemented for guests and staff.
- Wearing of appropriate personal protection equipment by staff with safe workplace procedures in place.
- Advice on precautionary measures for guests and staff to take for themselves as well to be vigilant and to monitor their health at all times.

Goodwood Park Hotel will continue to monitor the situation and may introduce other initiatives accordingly. We thank all our guests for their kind understanding and patience during these extraordinary times.

### Vaccination-Differentiated Safe Management Measures

We seek your cooperation for the following mandatory safe management measures (SMM), as well as your kind understanding that verification with every guest will be required before allowing engagement in any of the applicable activities, including dining in the restaurants, use of the Fitness Centre and participation in events.

Vaccination SMM Eligibility	Verification Requirements
1) <b>Fully vaccinated (2 weeks after final dose)</b> Applicable for full regimen of Pfizer-BioNTech / Comirnaty, Moderna or vaccines recognised in the WHO Emergency Use Listing  <i>or</i>  2) Not fully vaccinated/unvaccinated, but with a <b>valid negative result from a Pre-Event Test (PET) taken in the past 24hrs before the expected end of the event/activity</b> (i.e. PET validity to cover the event/activity duration)  <i>or</i>  3) A person who <b>recovered from COVID-19 within 270 days</b>	1) Present your vaccinated status via either your - TraceTogether / HealthHub app - Hardcopy or PDF vaccination status from HealthHub - Hardcopy vaccination card  2) Present your negative PCR result via either your - HealthHub app - Hardcopy COVID-19 test results notice (PCR) issued by GP clinics  3) Present your PET exemption notice obtained from GP clinics

For dining in, marriage solemnisations, wedding receptions and MICE events, please note that **children aged 12 years and below (i.e. born in and after 2009) must all be from the same household.**

Other fully vaccinated guests who fulfil any criteria from 1) to 3) can be from different households as the child / children.

For large-scale events, the number of children is capped at 20% of the actual event size.
