**Information for the data subject about the use of your personal data and your rights**

Dear Sir/Madam, in order to comply with Art. 13 of EU Regulation no. 2016/679 (hereinafter “the Regulation”), we would like to inform you that your personal data - personal details and in the form of photographic images or recordings using audiovisual means of your image and your voice - may be processed for the purpose of presenting company initiatives on the intranet site, on any website reserved for participants in the same event, and in publications, including hard copy publications, of companies belonging to Gruppo Unipol<sup>1</sup>, as well as for internal and/or external communication purposes for the business of Gruppo UNA S.p.A., in all existing media known today or that may appear in the future, with no limits to methods, time and space, but safeguarding the limit of the prohibition on its use in contexts that may appear prejudicial to your personal dignity or for decency.

The data, which will not be transferred to other countries, is processed by Gruppo UNA S.p.A. - the data controller with the right to free use of your images and your voice - using only methods and procedures, including computerised and electronic means, that are strictly necessary for the purposes mentioned and may be processed by employees of the Company or disclosed to companies in the Group<sup>1</sup>, and if necessary to third-party companies that we have directly authorised to pursue the purposes mentioned.

The data provided will be stored in full compliance with the security measures required by legislation on the protection of personal data and will be held for the time necessary to pursue the abovementioned aims: any publication means that processing will be limited to the times considered essential for promoting and advertising the event; where considered necessary, the images and recordings may be stored for longer for historical and documentary archiving purposes.

Providing your personal information is optional; if you refuse, we will not be able to advertise or publish your images and voice, but your participation in the event will not be jeopardised. You will be given the option of a place in an area where recordings are not being made, if you do not intend to consent to the processing of your images and/or your voice.

**Rights of the data subject**

Privacy laws (arts. 15-22 of the Regulation) guarantee you the right to access information concerning you at any time, to have it integrated and/or rectified, if it is inaccurate or incomplete, to cancel or limit its processing, if the conditions are met, to oppose its processing for legal reasons relating to your particular situation, and to the portability of the information you have provided, when processed using automated means, within the limits of the provisions of the Regulation (art. 20). The data controller of your personal data is Gruppo UNA S.p.A. ([www.gruppouna.it](http://www.gruppouna.it)) with headquarters in Via Gioacchino Murat 23 - 20159 Milan.

Furthermore, your right to lodge a complaint with the Italian Authority, the Privacy Guarantor, remains unaffected, if it is considered necessary in order to protect your personal information and your rights in this matter.
